We are writing to ask that the Mid-Atlantic Fishery Management Council look into the possibility of increasing the Trimester II Longfin squid quota. In two of the last three years Trimester II has closed early curtailing the summer fishery. Over the past five years a significant amount of the overall quota has remained uncaught. Increasing the Trimester II quota would allow the fishing industry to better utilize the Longfin squid quota and possibly allow for an uninterrupted summer fishery.
