The Catch Shares Committee met on March 8, 2012, in Savannah, GA. The Committee received a presentation on Voluntary Individual Fishing Quota Program for several species in the Snapper Grouper complex in the South Atlantic by representatives of the South Atlantic Fishermen's Association (SAFA).

The Committee made the following motions:

The agenda was adopted without any additions and the minutes of the December 2011 committee meeting were approved.

The committee received the following presentations:

- A. Status of Commercial Catches – Dr. Jack McGovern, NMFS SERO
- B. Status of Recreational Catches – Dr. Bonnie Ponwith, NMFS SEFSC
- C. North Carolina's Experience with State by State Quotas – Don Hesselman, NC Division of Marine Fisheries
- D. Importance of Tournament Sales of Fish – Jack Holmes, Managing Partner, Southern Kingfish Association
- E. Mackerel Tournament – Terry Adkins, Bluewater Promotions

The State Directors prepared data on the numbers of tournaments and catches in their state for use in Amendment 19. Doug Haymans reviewed the Georgia data and Michelle Duval gave a brief overview of the North Carolina Data. Jessica McCawley said they have very little data on sales by tournaments. The South Carolina data is being consolidated to avoid showing confidential data and will be provided.

The committee reviewed the scoping document for CMP Amendment 19 (Permits & Sale) and added/modified alternatives as shown below:

Action 1. Permits for Coastal Migratory Pelagic (CMP) species

- Option 1. No Action. Retain a single commercial king mackerel permit and a single commercial Spanish mackerel permit. Retain Gulf and South Atlantic Coastal Migratory Pelagic (CMP) charter/headboat permits.
- Option 2. Create a single commercial cobia permit.

Added Options 3 & 4:

- Option 3. Modify the Spanish mackerel permit to be a Spanish mackerel/cobia permit.**
- OPTION 4. ALLOW INDIVIDUALS WITH THE FOLLOWING PERMITS TO SELL COBIA: KING & SPANISH MACKEREL/REEFFISH/SNAPPER GROUPER/DOLPHIN WAHOO**

Directed staff to clarify whether the income requirements would be used.

Action 2. Potential No Sale Provisions

Modified Options 4 & 5 to read:

Option 4. For a person aboard a vessel to be eligible to sell cobia in or from the EEZ of the Atlantic or Gulf of Mexico, a commercial vessel cobia permit must have been issued to the vessel and must be on board

Option 5. Allow commercial sale of cobia with either a king mackerel or Spanish mackerel commercial permit

Action 3. Future participation in the commercial king and Spanish mackerel fisheries

3.1 Elimination of latent permits

3.1.1 In the Gulf group king mackerel gillnet sector – no change

3.1.2 In the king mackerel hook-and-line sector – no change

Action 4. Federal Regulatory Compliance – no change

Action 5. Modify or Eliminate Income Requirements for Gulf and South Atlantic Commercial Coastal Migratory Pelagic Permits – no change

Action 6. Spanish mackerel gillnet endorsement:

Directed staff to add the No Action alternative

The committee reviewed the scoping document for CMP Amendment 20 (Boundaries & Transit Provisions) and added/modified alternatives that affect South Atlantic fishermen as shown below (the committee was presented the suggested IPT changes but did not propose changes to actions only affecting the Gulf Council area):

Action 3. Establish a transit provision for fish harvested in the EEZ off Monroe County when the rest of the west coast of Florida is closed. NO CHANGES PROPOSED

Option 1. No action – do not establish a transit provision

Option 2. Establish a transit provision for fish harvested in the EEZ off Monroe County when the rest of the west coast of Florida is closed

Action 6. Establish state-by-state or regional quotas for Atlantic Migratory Group king mackerel, Spanish mackerel, and cobia.

Option 1. No Action – retain one commercial quota each for Atlantic migratory group of king mackerel, Spanish mackerel, and cobia

Option 2. Establish commercial quotas for each South Atlantic state for Atlantic migratory group of king mackerel, Spanish mackerel, and cobia.

Option 3. Establish commercial quotas for two regions: North Carolina/South Carolina and Georgia/Florida for Atlantic migratory group of king mackerel, Spanish mackerel, and cobia

Add a new Option 4

OPTION 4. ESTABLISH A COMMERCIAL QUOTA FOR NC AND ONE FOR SC/GA/FL COMBINED FOR KING & SPANISH MACKEREL AND COBIA

Add a new Option 5 and I so move to add Option 5. Establish a commercial quota for the Mid-Atlantic Council area for King & Spanish Mackerel and Cobia

MOTION: ADD OPTION 5. ESTABLISH A COMMERCIAL QUOTA FOR THE MID-ATLANTIC COUNCIL AREA FOR KING & SPANISH MACKEREL AND COBIA APPROVED BY COMMITTEE

Action 7. Establish an eastern zone within the Gulf migratory group of cobia and modify the framework to provide that the SAFMC is to set regulations within this zone. In addition, establish a southern subzone within the Atlantic migratory group of cobia.

Option 1. No Action. The boundary between migratory groups of cobia is the Council boundary.

Option 2. Establish an eastern zone within the Gulf migratory group of cobia to include the Florida east coast south of Cape Canaveral and the Atlantic side of the Keys. Establish a southern subzone within the Atlantic migratory group of cobia to include Georgia and northeast Florida.

Option 3. Establish an eastern subzone within the Gulf migratory group of cobia to include the entire Florida east coast and the Atlantic side of the Keys. Establish a southern subzone within the Atlantic migratory group of cobia to include Georgia.

The committee directed the staff and IPT to work on the wording for describing the modifications needed for the Atlantic Migratory Group under Action 7.

Snapper Grouper Committee Report
March 8, 2012
Savannah, GA

The Snapper Grouper Committee met in Savannah on March 8, 2012.

The Committee received reports from SERO and the SEFSC on the status of commercial and recreational landings for species under quota management, respectively. The Committee also received updates from SERO staff on the status of amendments under review, including the Comprehensive ACL Amendment and Amendment 18A. The Committee discussed the fact that the latter was submitted for formal review with the incorrect preferred alternative for Action 6 (Endorsement Transferability). The RA informed the Committee that Action 6 would be disapproved and the Council would have to prepare a new document for submission to implement the correct alternative for endorsement transferability. In addition, the Committee was informed by the RA that Amendment 18A would likely not be implemented by the June 1, the beginning of the black sea bass fishing year. The Committee made the following motions:

MOTION: STAFF PREPARE A DOCUMENT TO ALLOW FOR TRANSFERABILITY OF ENDORSEMENTS AND ADDRESS THE RENEWAL OF ENDORSEMENTS SEPARATELY FROM THE SG PERMIT. BRING THIS TO THE COUNCIL FOR FINAL ACTION AT THE JUNE MEETING

Regulatory Amendment 12 (Golden Tilefish)

The Committee received an overview from Council staff on Regulatory Amendment 12 and made the following motions:

MOTION: ADOPT ALTERNATIVE 5 UNDER ACTION 1 AS OUR PREFERRED

Action 1. Revise Annual Catch Limit (ACL) and Optimum Yield (OY) for Golden Tilefish

Alternative 5. ACL = OY = yield at 75%FMSY when stock is at equilibrium (625,000 POUNDS WW).

MOTION: SELECT ALTERNATIVE 2 UNDER ACTION 2 AS OUR PREFERRED

Action 2. Establish an Annual Catch Target (ACT) for the Golden Tilefish Commercial Sector

Alternative 2. Establish an Annual Catch Target (ACT) for the golden tilefish commercial sector = 90% of the commercial sector ACL. (Preliminary estimate = 158,512 pounds gw)

****The Council's intent is that if the commercial ACT is met, or projected to be met, the commercial fishery would be closed; harvest and possession would be limited to the bag limit and no sale would be allowed****

Amendment 18B/EA (Golden Tilefish)

The Committee made the following motions pertaining to Amendment 18B:

MOTION: ACCEPT THE IPT'S RECOMMENDATIONS FOR THE NEW PURPOSE AND NEED

Purpose for Action: The purpose of Amendment 18B is to limit participation in the golden tilefish portion of the snapper grouper fishery through establishment of longline ~~and hook and line~~ endorsements, changes to the fishing year, allocation of the Annual Catch Limit (ACL) between gear groups, AND modifications to golden tilefish trip limits, ~~and updates to the ACL and AMs based on the most recent stock assessment.~~

The actions proposed in this amendment will address issues that have arisen as a result of a more stringent regulatory regime in the South Atlantic region.

Need for Action: The need for action in Amendment 18B is to reduce overcapacity in the golden tilefish portion of the snapper grouper fishery ~~and to update the ACL and other values based on the most recent stock assessment.~~

Action 1. Limit Participation in the Golden Tilefish Component of the Snapper Grouper Fishery

Limit golden tilefish effort through a golden tilefish gear endorsement program: Distribute golden tilefish gear specific endorsements for snapper grouper permit holders that qualify under the eligibility requirements stated below. Only snapper grouper permit holders with a golden tilefish longline endorsement or a golden tilefish hook and line endorsement associated with their snapper grouper permit will be allowed to possess golden tilefish.

Sub-alternative 2a (Preferred). Individuals that meet the qualifying criteria for both hook and line and longline endorsements may receive both endorsements.

Speckled Hind and Warsaw Grouper (CE-BA 3)

The Committee discussed the approach to be taken regarding possible establishment of Marine Protected Areas (MPAs) to reduce mortality of speckled hind and warsaw grouper. The Committee provided the following guidance to staff on timing and approach:

DECISION #1. Type of Closures to be evaluated. Evaluate Alternatives 3 and 4:

Alternative 3. Area closures where all bottom fishing is prohibited (same type of MPAs currently in place).

Alternative 4. Temporary area closures that would remain in place until we get an assessment for speckled hind and warsaw grouper and the results indicate some relaxation of regulations is warranted.

DECISION #2. Approaches for developing potential area closures (MPAs) – alternatives are sufficient; directed staff to look at Tortugas and other areas that may be providing protection.

DECISION #3. Guidance on what percentage (of occurrence or habitat) is “appropriate” to be closed. Evaluate alternatives 3, 4 and 5:

Alternative 3. Establish a goal of 20%

Alternative 4. Establish a goal of 30%

Alternative 5. Establish a goal of 40%

DECISIONS #4 & #5 – evaluate 20%, 30%, & 40% and timing/workshops to be discussed at full Council.

National System of MPAs

The Committee received a presentation from George Geiger and Lauren Wenzel on the National System of MPAs. The presentation included background on the program and the benefits that would result from the Council’s participation. The Committee provided guidance to include discussion of possible nomination of protected areas in the South Atlantic during upcoming meetings of the Habitat and Coral Advisory Panels.
